#### **Introductions & Welcome**

Chief Páez welcomed the members and guests to the meeting.

#### Approval of January 21, 2022 Minutes

Mr. Kille motioned to approve the minutes from April 29, 2022; Second: Chief Woods motion passed

#### Treasurer's Report:

Mr. Brandt provided the board with a copy of the financial report provided by Mr. O'Brien. Chief Farmer motioned to accept the financial report as submitted; Second Chief Páez, motion passed

The Board also discussed the fund balance policy. The current policy calls for no less than 100% of the budgeted General Fund operating expenditures. Due to the changes with the Motorola maintenance contract, we would need to increase our fund balance.

Discussion on the 2023 Draft budget. Mr. Brandt indicated we increased the maintenance expenses due to generator and HVAC systems repair cost. Mr. Somerville reported the maintenance contract on the generators does not include repair only inspections.

## Resolution 2022-07: Updating the General Fund Balance Policy

Due to a change in the Motorola Maintenace contract the revenue and expenditures have increased.

Revise section III to read: At the time of the budget preparation, the annual appropriations shall be adjusted to ensure that the estimated year-end Fund Balance is equal to or greater than 25% of the previous year's revenue.

Revise Section IV to include The Board may utilize any funds greater than 25% to offset annual expenses.

Mr. Kille motioned to approve; Second: Mr. Greeson; Motion passed.
