Approval of October 25, 2024 Minutes

Chief Woods motioned to approve the minutes from October 25, 2024; Second: Chief Zimmer, motion passed.

Treasurer's Report

Ms. Yankanin provided an overview of the financial report in Ms. Jaime Hoffman's absence.

- Ended the year with a fund balance increase of \$52,454.02 for a final year-end balance of \$483,075.95.
- There was a \$3000 budget transfer in November from Other Professional Services to Equipment Maintenance to cover additional repairs needed at Worthington Tower by AirForce One.
- We carried over \$21,128.14 in outstanding encumbrances to 2025. Ms. Hoffman will evaluate whether any of these can be closed.
- Partners will be invoiced for their member fees next month.

Technical Committee Report

Mr. Harris and Mr. Waldo have been working to track down an illegal carrier on channel 7/8. In working with MARCS, they determined that the offender was coming from a BDA at an Amazon facility. The BDA was turned off for now. Mr. Waldo noted that Motorola would be on site in Delaware to provide information on their Five-Year Plan. Mr. Harris will likely attend.

Mr. Harris noted the SIEC meeting coming up January 22. He and Chief Zimmer will attend.
