- Chief Páez advised that he received another invoice from Taft regarding the Huntley Tower and is going to follow up with Ms. Hoffman on the overpayment noted on the quarterly report.
 - Ms. Stewart noted that regarding Huntley, they are working on the last piece of information that is needed by Taft from Worthington, the property survey.

- The extension for P25 authentication was mentioned. Chief Woods advised that this was
 discussed at the COMCAC meeting, and while there is a provision for fines after a certain date,
 MARCS will do what they can to avoid fining anyone.
